- (2) Proposal #2 Motion by SMHA Member Frank DiFebo to amend Article 3.4 of the King Township Minor Hockey Association Bylaws to require the Local League Organizations to operate teams out of their community arenas "in perpetuity". Specific Motion Language and Proposed Bylaw Amendment will be Published on the SMHA Website and Posted at the SMHA Office.
- (3) <u>Proposal #3</u> Motion by SMHA Member Frank DiFebo to amend Article 7.1 of the King Township Minor Hockey Association Bylaws to ban all "AE" Level Rep teams "present and future". Specific Motion Language and Proposed Bylaw Amendment will be Published on the SMHA Website and Posted at the SMHA Office.
- (4) <u>Proposal #4</u> Motion by SMHA Member Frank DiFebo to amend the Termination Provision of the King Township Minor Hockey Agreement during the 2 year Trial Period, as set out in Article 31.1 of the King Township Minor Hockey Association Bylaws. Specific Motion Language and Proposed Bylaw Amendment will be Published on the SMHA Website and Posted at the SMHA Office.
- (5) Proposal #5 Motion by SMHA Member Frank DiFebo to amend the to amend the Termination Provision of the King Township Minor Hockey Agreement after the 2 year Trial Period, as set out in Article 31.2 of the King Township Minor Hockey Association Bylaws. Specific Motion Language and Proposed Bylaw Amendment will be Published on the SMHA Website and Posted at the SMHA Office.

Election of Board positions at this AGM could vary, depending upon whether the Bylaw Amendments set out in Proposal #1 are accepted by the Membership. If Proposal #1 is successfully passed, the SMHA Board will change in size and structure, to a smaller group of Local League Directors, recognizing that a number of operational and administrative functions will now be carried out by King Township Minor Hockey and not at the Local League level. If this proposal passes, elections will take place for a newly constituted SMHA Board of Directors as follows:
