***Additional information regarding board positions:***

In the normal course, each Director shall hold office for a two (2) year term provided that in the first year following the issue of the Letters Patent, all Directors on both Slates will stand together for election concurrently, with the Directors on "Slate A" being elected for a term of two (2) years each, and Directors on "Slate B" will be elected for a term of one (1) year each. Following the first set of elections, and once an appropriate rotation has been established, the applicable term for all Directors will be two (2) years.

Additional detailed descriptions for all board positions and committees can be found in the constitution.

**PRESIDENT**

The nominee for the President shall have served on the present Board of Directors, and shall be elected at the AGM to serve a **two-year term (except for the 2018/19 season, which is a one-year term)**, and no more than two (2) terms. The President shall be the Chief Executive Officer of the Corporation.

**1<sup>ST</sup> VICE-PRESIDENT/DIRECTOR OF REP HOCKEY**

The nominee for the 1<sup>ST</sup> Vice-President shall be elected at the AGM to serve a **two-year term**. Shall assist the President in his/her duties, and, in the absence of the President shall perform the duties and exercise the powers of the President.

**2<sup>ND</sup> VICE PRESIDENT/DIRECTOR OF LOCAL LEAGUE HOCKEY**

The nominee for the 2<sup>ND</sup> Vice President shall be elected at the AGM to serve a **two year term**. Shall be the Corporation's singular point of communication with the offices of the Simcoe Region Local League (SRL), and shall represent the Corporation at Regional meetings with other associations in the SRL.

**FUNDRAISING AND SPECIAL EVENTS DIRECTOR**

The nominee for the Fundraising and Special Events Director shall be elected at the AGM to serve a **two-year term**. Shall chair and supervise all association approved fund-raising projects **and special events**, organize team pictures, actively pursue fundraising projects and sponsorship on behalf of the corporation, and other related duties.

**EQUIPMENT DIRECTOR**

The nominee for the Equipment Director shall be elected at the AGM to serve a **two-year term (except for the 2018/19 season, which is a one-year term)**. Shall be responsible for the collection and distribution of hockey shirts, socks, sponsor name bars, player name bars, and equipment.

**TOURNAMENT DIRECTOR**

The nominee for the Tournament Director shall be elected at the AGM to serve a **two-year term**. Shall be responsible to organize, or cause to be organized all major tournaments being hosted by the Corporation.

**HEAD COACH DIRECTOR**

The nominee for the Head Coach Director shall be elected at the AGM to serve a **two-year term (except for the 2018/19 season, which is a one-year term)**. Shall be responsible for providing guidance and mentoring to Coaches as needed, including the promotion of consistent skill development curriculum, and participation in the selection of Local League and Rep Coaches.

**DEVELOPMENT DIRECTOR**

The nominee for the Development Director shall be elected at the AGM to serve a **two-year term**. Shall be responsible for organizing all Player and Coach development.
